1 District Courts. As part of such answer, respondent shall state whether petitioner has exhausted 2 available state remedies and whether an evidentiary hearing is necessary. Respondent shall not 3 file a dispositive motion in place of an answer without first showing cause as to why an answer is 4 inadequate. Respondent shall file the answer with the Clerk of the Court and serve a copy of the 5 answer on petitioner.

6 (3) The answer will be treated in accordance with LCR 7(d)(3). Accordingly, on the
7 face of the answer, respondent shall note it for consideration on the fourth Friday after filing.
8 Petitioner may file and serve a response not later than the Monday immediately preceding the
9 Friday designated for consideration of the matter, and respondent may file and serve a reply not
10 later than the Friday designated for consideration of the matter.

(4) Filing by Parties, Generally

All attorneys admitted to practice before this Court are required to file documents electronically via the Court's CM/ECF system. Petitioner shall file all documents electronically.
