STIPULATION AND AGREED ORDER CONTINUING TRIAL DATE AND RELATED DEADLINES

STIPULATION

Plaintiff Satbinder Athwal by and through her counsel, and Defendants Jay Nijjer, "Jane Doe" Nijjer and Indigo Holdings, LLC (collectively "Defendants"), stipulate and jointly move the Court for an order continuing the trial date in this matter from March 5, 2018 to June 4, 2018, and adjusting the pre-trial deadlines accordingly.
