20 This is a claim for long-term disability benefits Plaintiff is eligible to receive through his  
21 employment with Boeing. Defendants initially denied Plaintiff’s claim for long-term disability  
22 benefits by letter, dated June 7, 2016. Plaintiff appealed the denial and submitted additional,  
23 supportive medical information to support his disability. Defendant upheld the initial denial by
