ORDER ON UNOPPOSED
MOTION FOR EQUAL ACCESS
TO JUSTICE ACT FEES AND
EXPENSES



17 This Court has jurisdiction pursuant to 28 U.S.C. § 636(c), Fed. R. Civ. P. 73 and Local
18 Magistrate Judge Rule MJR 13 (*see also* Consent to Proceed Before a United States Magistrate
19 Judge, Dkt. 2). This matter is before the Court on plaintiff's Unopposed Motion for Equal Access
20 to Justice Act Fees and Expenses (*see* Dkt. 14).

21 Based on the Equal Access to Justice Act, 28 U.S.C. § 2412, ("EAJA"), the stipulation of
22 the parties (*see* Dkt. 14, Attachment 4), attorney time and expense itemizations (Dkt. 14,
23 Attachment 2), and the relevant record, it is hereby ORDERED that EAJA attorney's fees of
24 \$8,855.55 and expenses of \$26.10, shall be awarded to plaintiff pursuant to the EAJA and

1 consistent with *Astrue v. Ratliff*, 130 S.Ct. 2521, 2524, 2010 U.S. LEXIS 4763 at ***6-***7
2 (2010).

3 The Acting Commissioner shall contact the Department of Treasury after the Order for
4 EAJA fees and expenses is entered to determine if the EAJA fees and expenses are subject to any
5 offset. If it is determined that plaintiff's EAJA fees and expenses are not subject to any offset
6 allowed pursuant to the Department of the Treasury's Offset Program, then the check for EAJA
7 fees and expenses shall be made payable to George Andre Fields, Esq., based on plaintiff's
8 assignment of these amounts to plaintiff's attorney (*see* Fee Agreement, Dkt. 14, Attachment 3).
9 If there is an offset, the remainder shall be made payable to plaintiff, based on the practice of the
10 Department of the Treasury (*see, e.g.*, Case No. 2:15-cv-122, Dkt. 22, p. 4). Any check for EAJA
11 fees and expenses shall be mailed to plaintiff's counsel, George Andre Fields, Esq. at P.O. Box
12 231024, Sacramento, CA 95823.
