**Order Granting Motion to Issue
Continuing Garnishee Order**

THIS MATTER comes before the Court on the United States' Motion to Issue Continuing Garnishee Order, docket no. 10, (the "motion"). For the reasons stated herein, the motion is GRANTED.

A Writ of Continuing Garnishment, directed to Garnishee, Allied Trade Group, LLC, aka Lowe's Companies, Inc. (Allied Trade Group), docket no. 3, has been duly issued and served upon the Garnishee. Pursuant to the Writ,

1 Garnishee Allied Trade Group filed an Answer on July 17, 2017, docket no. 8,
2 stating that at the time of the service of the Writ, Defendant/Judgment Debtor
3 Christopher Mark Williams (Mr. Williams), was an active employee who was
4 paid bi-weekly.
5

6 After notification of the garnishment proceeding was mailed to the
7 parties on or about June 29, 2017, the Defendant/Judgment Debtor
8 requested a hearing, which was subsequently denied by Judge Zilly on
9 August 14, 2017.
10

11 THEREFORE, having considered the motion, Mr. Williams' letter to the
12 Court, docket no. 12, which the Court treats as a response to the motion, *see*
13 docket no. 14, and the United States' reply, docket no. 15, the Court orders as
14 follows:


16 That the Garnishee, Allied Trade Group, shall pay to the United States
17 District Court for the Western District of Washington, the non-exempt
18 earnings payable to Defendant/Judgment Debtor Christopher Mark Williams,
19 upon each period of time when Defendant/Judgment Debtor Williams is
20 entitled to receive such funds, and shall continue said payments, if any, until
21 Defendant/Judgment Debtor Williams' debt is paid in full or until
22 Defendant/Judgment Debtor is no longer an active employee of Garnishee
23 and the Garnishee no longer has possession, custody, or control of any funds
24 due and owing to the Defendant/Judgment Debtor or until further order of
25 this Court. This includes all monies required to be previously withheld by the
26 Garnishee, in accordance with the Writ of Continuing Garnishment;

1 That such payments shall be applied to Defendant/Judgment Debtor
2 Williams' outstanding restitution obligation, by the United States District
3 Court for the Western District of Washington; and

5 That the payments shall be made out to the United States District
6 Court, Western District of Washington, referencing Case Nos. 2:06-CR-00415-
7 RSL-1 and 2:17-CV-01048-TSZ, and to deliver such payment either
8 personally or by First Class Mail to:
