3 1. The Court's Second Amended Jury Trial Scheduling Order, ECF No.

5 **TRIAL DATES**

6 **1. Jury Trial.** The jury trial set is set for **February 28, 2023**, at **9:00 a.m.** in
7 **SEATTLE**, Washington. Counsel estimates a trial length of five days.

8 **2. Pretrial Conference.** An in person pretrial conference will be held on
9 **February 6, 2023**, at **9:00 a.m.**, in **Seattle, Washington**.

11 **3. Motions *in Limine*.**

12 A. *Motions in Limine:* The motions in limine previously filed will be heard
13 at the Pretrial Conference.

14 B. *Responses to the previously filed motions in limine:* shall be filed and
15 served on or before **January 17, 2023**.

16 C. *Replies:* shall be filed and served on or before **January 24, 2023**.

17 **TRIAL PREPARATION DEADLINES**

18 **4. Exhibit and Witness Lists.**

19 A. *Exhibit Lists and Witness Lists:* shall be filed and served and exhibits
20 made available for inspection (or copies provided), on or before **January 17, 2023**.

21 D. *Objections:* Objections to the opposing party's witness list or exhibit list
22 and any accompanying briefs shall be filed and served on or before **January 24,**
23 **2023**.

24 E. *Responses:* Responses, if any, to objections shall be filed and served on or
25 before **January 31, 2023**.

26 **5. Pretrial Exhibit Stipulation.**

27 B. *Deadline:* The pretrial exhibit stipulation shall be filed on **January 31,**
28 **2023**.

1 **6. Designation of Testimony.**

2 A. Cross-Designations shall be filed on or before **January 9, 2023.**

3 B. Objections to Designations shall be filed on or before **January 17, 2023.**

4 C. If objections are filed, a hearing on the objections will be held on
5 **January 23, 2023, at 9:00 a.m., in Seattle, Washington.**

6 **7. Pretrial Order.**

7 A. *Deadline:* A joint Pretrial Order, prepared in accordance with the format
8 provided in Local Rule 16.1(b), shall be filed on or before **January 31, 2023** and a
9 copy e-mailed in Word format to the Court at bastianorders@waed.uscourts.gov.

10 **8. Trial Briefs and Proposed Voir Dire.** Trial briefs and voir dire shall be filed by
11 **February 1, 2023.**

12 **9. Jury Instructions.** No later than **January 31, 2023**, the parties shall file jointly
13 proposed jury instructions.

14 **IT IS SO ORDERED.** The District Court Clerk is hereby directed to enter
15 this Order and to provide copies to counsel.
