WHEREAS, Plaintiff Leonard A. Lemmon, and Defendant Equifax Information Services LLC ("Equifax"), by counsel, submitted a Stipulation on July 16, 2018 to extend the deadlines related to discovery and class certification, which was approved by the Court on July 17, 2018 (Docs. 27, 28);

WHEREAS, this case is one of a number of similar putative class actions brought against Equifax around the country regarding the reporting of public records (*i.e.*, tax liens and civil judgments);

WHEREAS, on October 9, 2018, the parties in these putative class actions reached an agreement in principle to resolve the pending cases on a nationwide basis through a class

1 settlement to be presented for approval in the Eastern District of Virginia. The settlement, if
2 approved, would resolve the putative class action claims in this case;

3 WHEREAS, good cause therefore exists to stay the deadlines in this matter for 60
4 days until December 21, 2018, while the parties negotiate a formal settlement agreement;

5 **I. STIPULATION**

6 NOW THEREFORE, the Parties jointly stipulate and agree that the deadlines
7 currently set in this case pursuant to the Court's July 17, 2018 Order (Doc. 28) be stayed by
8 60 days. The parties will update the Court and provide a status report by no later than
9 December 21, 2018 regarding the status of the settlement.
