20 The following Minute Order is made by direction of the Court, the Honorable
21 Thomas S. Zilly, United States District Judge:

22 (1) Plaintiff's Motion for Leave to Proceed Under Pseudonym and for
23 Protective Order, docket no. 3 in C17-1572, and Motion for Leave to Proceed Under
Pseudonyms as Provided by a Proposed Protective Order, docket no. 21 in C17-1681,
are DENIED. Plaintiff has not demonstrated that anonymity protection is warranted or
otherwise established good cause for a protective order. Plaintiff is DIRECTED to file

1 with the Court a document identifying “John Doe,” “John Doe PLLC,” and “Janet Roe”
2 no later than January 30, 2018. The parties are DIRECTED to follow the procedures set
forth in LCR 26(c) prior to filing any subsequent motions for a protective order.

3 (2) Plaintiff’s motion for extension of time, docket no. 10 in C17-1681, is
STRICKEN as moot. Plaintiff has already responded to the motion to dismiss filed by
4 Defendants Seatree PLLC and James J. Namiki, docket no. 7 in C17-1681. See docket
no. 12 in C17-1681.

5 (3) Plaintiff’s motion for reconsideration, docket no. 23 in C17-1572, is
6 RENOTED to January 12, 2018. Defendants Seatree PLLC and James J. Namiki are
DIRECTED to file their response, if any, to Plaintiff’s motion for reconsideration,
7 docket no. 23 in C17-1572, no later than January 12, 2018. Plaintiff shall not file any
reply unless ordered to do so by the Court.

8 (4) Both motions to dismiss filed by Defendants Seatree PLLC and James J.
9 Namiki, docket no. 9 in C17-1572 and docket no. 7 in C17-1681, are RENOTED to
February 9, 2018.

10 (5) The Clerk is directed to send a copy of this Minute Order to all counsel of
11 record.
