**[PROPOSED] ORDER GRANTING

THIS MATTER came on to be heard upon the Verified Complaint and Motion for Issuance of Warrants for Arrest of plaintiffs Stanley G. Simonson and Rebecca I. Simonson seeking an Order authorizing the arrest of the following under Rule C and Rule E of the

1 Supplemental Rules for Admiralty and Maritime Claims to the Federal Rules of Civil
2 Procedure and LAR 116:

3 (1) The M/V LUCKY BUCK, Official Number 567411, and its engines,
4 machinery, tools, fishing nets and other fishing gear, fish processing equipment, boats,
5 anchors, chains, tackle, fittings, navigation equipment, and all other equipment and
6 appurtenances appertaining or belonging to such vessel, whether now owned or hereafter
7 acquired, and whether on board or not; all present and future accessions to such vessel,
8 equipment and appurtenances, and all other additions, improvements, and replacements
9 hereafter made in or to such vessel, equipment and appurtenances to the M/V LUCKY
10 BUCK, and
11

12 (2) The M/V SPEEDWELL, Official Number 594754, and its engines, machinery,
13 tools, fishing nets and other fishing gear, fish processing equipment, boats, anchors, chains,
14 tackle, fittings, navigation equipment, and all other equipment and appurtenances appertaining
15 or belonging to such vessel, whether now owned or hereafter acquired, and whether on board
16 or not; all present and future accessions to such vessel, equipment and appurtenances, and all
17 other additions, improvements, and replacements hereafter made in or to such vessel,
18 equipment and appurtenances to the M/V SPEEDWELL
19

20 Having reviewed the record and having considered the evidence, in particular the
21 Verified Complaint; the Motion; and any response or reply thereto; and the pleadings and
22 records on file herein; and the Court being fully advised; now, therefore, the Court FINDS:
23

24 (1) The conditions for an in rem action against the vessel M/V LUCKY BUCK
25 appear to exist pursuant to Rule C(3)(a)(i) of the Supplemental Rules of Admiralty and
26 Maritime Claims;

1 (2) The conditions for an in rem action against the vessel M/V SPEEDWELL
2 appear to exist pursuant to Rule C(3)(a)(i) of the Supplemental Rules of Admiralty and
3 Maritime Claims;

4 (3) The M/V LUCKY BUCK is currently moored at Lake Union Drydock, and is
5 accordingly within the Western District of Washington and the jurisdiction of this Court;

6 (4) The M/V SPEEDWELL is currently moored at Lake Union Drydock, and is
7 accordingly within the Western District of Washington and the jurisdiction of this Court;

8 (5) The Simonsons are entitled to seek enforcement of their preferred mortgage
9 maritime lien and foreclosure of the Preferred Ship Mortgage secured by the M/V LUCKY
10 BUCK;

11 (6) The Simonsons are entitled to seek enforcement of their preferred mortgage
12 maritime lien and foreclosure of the Preferred Ship Mortgage secured by the
13 M/V SPEEDWELL;

14 IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that the arrest of the
15 vessels M/V LUCKY BUCK and the M/V SPEEDWELL is authorized.
