August 9, 2018**

Pursuant to LCR 7(d)(1) and LCR 10(g), Plaintiff Ryanair DAC (“Ryanair”) and defendant Expedia, Inc. (“Expedia”), by and through their counsel, hereby stipulate and move for a fifteen-day extension of the deadline for Expedia’s answer to Ryanair’s Complaint pursuant to FRCP 12(a)(4)(A).

STIPULATED MOTION

The parties hereby stipulate as follows:

Ryanair filed its Complaint on November 29, 2017 (Dkt. #1), and Expedia moved to dismiss the Complaint. (Dkt. #34) Pursuant to Federal Rule of Civil Procedure 12(a)(4)(A), Expedia’s answer to Ryanair’s Complaint is due on August 20, 2018. Due to counsel’s pre-planned and pre-paid vacation schedule, and as a professional courtesy, the parties agree and stipulate that good cause exists to continue the deadline for Expedia to file its answer for fifteen days, to **September 4, 2018**.
