TRIAL AND RELATED DATES

15 The following Minute Order is made by direction of the Court, the Honorable
16 Thomas S. Zilly, United States District Judge:

17 JURY TRIAL DATE	May 13, 2019
18 Length of Trial	5 days
19 Discovery on class certification issues completed by	April 23, 2018
20 Any motions related to class certification must be filed by	June 21, 2018
21 Deadline for joining additional parties	July 31, 2018
22 Any motions for leave to amend pleadings filed by	August 16, 2018
23 Disclosure of expert testimony under FRCP 26(a)(2)	September 4, 2018
All motions related to discovery must be filed by	September 20, 2018

1	All remaining discovery completed by	October 18, 2018
2	All dispositive motions must be filed by	December 13, 2018
3	All motions <i>in limine</i> must be filed by	March 28, 2019
4	and noted for the third Friday thereafter; responses	
5	shall be due on the noting date; no reply shall be	
6	filed unless requested by the Court	
7	Agreed pretrial order due	April 26, 2019
8	Trial briefs, proposed voir dire questions, and	April 26, 2019

10	Pretrial conference to be held at 1:30 p.m. on	May 3, 2019

11 These dates are set at the direction of the Court after reviewing the joint status
12 report and discovery plan submitted by the parties. All other dates are specified in the
13 Local Civil Rules. These are firm dates that can be changed only by order of the Court,
14 not by agreement of counsel or the parties. The Court will alter these dates only upon
15 good cause shown: failure to complete discovery within the time allowed is not
16 recognized as good cause.

17 As required by LCR 37(a), all discovery matters are to be resolved by agreement if
18 possible. Counsel are further directed to cooperate in preparing the final pretrial order in
19 the format required by LCR 16.1, except as ordered below.

20 The original and one copy of the trial exhibits are to be delivered to the courtroom
21 the morning of the trial. Each exhibit shall be clearly marked. Plaintiff's exhibits shall
22 be numbered consecutively beginning with 1; defendant's exhibits shall be numbered
23 consecutively beginning with the next multiple of 100 after plaintiff's last exhibit. For
example, if plaintiff's last exhibit is numbered 159, then defendant's exhibits shall begin

1 with the number 200. Duplicate documents shall not be listed twice: once a party has
2 identified an exhibit in the pretrial order, any party may use it. Each set of exhibits shall
3 be submitted in a three-ring binder with appropriately numbered tabs.

4 Counsel must be prepared to begin trial on the date scheduled, but it should be
5 understood that the trial may have to await the completion of other cases.

6 Should this case settle, counsel shall notify Karen Dews at 206-370-8830 as soon
7 as possible.

8 The Clerk is directed to send a copy of this Minute Order to all counsel of record.
