

1 motion, the Court finds that the motion should be granted. Accordingly, the
2 Court orders as follows:

3 1. Garnishee Skills Inc. shall pay to the Court the \$1,665.00 it has
4 withheld from Defendant/Judgment Debtor James Rubin Rowe's
5 earnings pursuant to the Writ of Garnishment;

6 2. Skills Inc. shall make its payment via a check payable to the U.S.
