

1 Assessment, entered in *United States v. Edmond Joseph McNeal*, No. 2:02-CR-0246-1, United
2 States District Court for the Western District of Washington (November 22, 2002). A balance
3 of \$65,336.00 remains outstanding as of March 10, 2017. The following is required:

4
5 1. You are required by law to Answer in writing, under oath, within **ten (10) days**,
6 whether you have in your possession, custody or control, any property in which the
7 Defendant/Judgment Debtor has a substantial nonexempt interest, including nonexempt,
8 disposable earnings. **Please use** the "Form Answer" that accompanies this Writ.

9
10 2. You are required to immediately withhold and retain any and all property in which
11 the Defendant/Judgment Debtor has a substantial nonexempt interest and for which you, the
12 Garnishee, are or may become indebted to the Defendant/Judgment Debtor pending further
13 order of the Court. The nonexempt amount of a person's earnings/wages is typically 25 percent
14 of disposable, *i.e.*, after-tax, earnings. *See* 15 U.S.C. § 1673.

15
16 3. You must File the Original Answer of the Garnishee to this Writ within **ten (10)**
17 **days** of your receipt of this Writ with the United States District Court Clerk for the Western
18 District of Washington, 700 Stewart Street, Lobby Level, Seattle, WA 98101.

20 4. Additionally, you are required by law to Serve in person or by First Class Mail a
21 copy of the Answer of the Garnishee to this Writ (1) upon the Defendant/Judgment Debtor,
22 Edmond Joseph McNeal, 14677 SE Fairwood Blvd., Renton, WA 98058, and (2) upon the
23 United States Attorney's Office, Western District of Washington, Assistant United States
24 Attorney, Kyle Forsyth, Attn: Financial Litigation Unit, 700 Stewart Street, Suite 5220, Seattle,
25 WA 98101.

27 5. Under the law there may be property which is exempt from this Writ of Continuing
28 Garnishment. Property which may be exempt and which may not be subject to this Order is

1 listed in the accompanying "Claim for Exemption Form," including the Consumer Credit
2 Protection Act provision of 15 U.S.C. § 1673.

3 6. Pursuant to 15 U.S.C. § 1674, you, the Garnishee, are prohibited from discharging
4 the Defendant/Judgment Debtor from employment, should he be employed by you, because his
5 earnings have been subject to garnishment for any one indebtedness.
6

7 If you fail to Answer this Writ or withhold property in accordance with this Writ, the
8 United States of America may petition the Court for an Order requiring you to appear before
9 the Court. If you fail to appear or do appear and fail to show good cause why you failed to
10 comply with this Writ, the Court may enter a judgment against you for the value of the debtor's
11 non-exempt property. It is unlawful to pay or deliver to the Defendant/Judgment Debtor any
12 property attached by this Writ.
