**Agreed Continuing Garnishee  
Order**

19 A Writ of Continuing Garnishment directed to Garnishee, Career Paths  
20 NW, LLC, has been duly issued and served upon the Garnishee. Pursuant to  
21 the Writ, Garnishee Career Paths NW, LLC, filed its Answer on April 28, 2017,  
22 stating that at the time of the service of the Writ, Defendant/Judgment Debtor  
23 Edmond Joseph McNeal (Mr. McNeal) was an active employee who was paid  
24 monthly.  
25

26 After notification of the garnishment proceeding was mailed to the  
27 parties on or about April 18, 2017, the Defendant/Judgment Debtor has not

1 requested a hearing to determine exempt property as of this date. On May 15,  
2 2017, the United States filed an Agreed Motion to Issue Continuing Garnishee  
3 Order, stating that it had agreed with Mr. McNeal to request a reduced  
4 garnishment rate of 15 percent of his disposable earnings at Garnishee Career  
5 Paths NW, LLC. The United States attached a Proposed Agreed Continuing  
6 Garnishee Order to that effect, jointly presented with Mr. McNeal and bearing  
7 his signature.  
8

9 IT IS THEREFORE ORDERED as follows:

10 That the Garnishee, Career Paths NW, LLC, shall pay to the United  
11 States District Court for the Western District of Washington, all non-exempt  
12 earnings payable to Mr. McNeal, that it has previously withheld pursuant to  
13 the Writ of Garnishment;  
14

15 That from this date forward, Garnishee Career Paths NW, LLC, shall  
16 pay to the United States District Court for the Western District of Washington,  
17 15 percent of the disposable earnings, less the amount withheld for child  
18 support, payable to Mr. McNeal upon each period of time when Mr. McNeal is  
19 entitled to receive such funds, and shall continue said payments, if any, until  
20 Mr. McNeal's debt is paid in full or until he is no longer an active employee of  
21 Garnishee and the Garnishee no longer has possession, custody or control of  
22 any funds due and owing to Mr. McNeal or until further order of this Court;  
23

24 That such payments shall be applied to Mr. McNeal's outstanding  
25 obligation, by the United States District Court for the Western District of  
26 Washington; and

1 That the payments shall be made out to the United States District  
2 Court, Western District of Washington, referencing Case Nos. 2:02-CR-00246-  
3 MJP-1 and 2:17-MC-00028-RSL, and delivered either personally or by First  
4 Class Mail to:
