1 nonexempt monies of defendants, 123 DIRECT LTD d/b/a 123 DIRECT USA dba 123
2 HEALTHSHOP; JOSE MANUEL-MENDEZ NAVARRO; JEREMY MICHAEL ROURKE-
3 PILOTT in the sum of \$20,747.13, that plaintiff has judgment unsatisfied against the defendants
4 in a sum in excess of that amount, that a signed affidavit or return of service indicating that the
5 Writ of Garnishment and application for the Writ were served on defendants as required by the
6 laws of the State of Washington, that more than twenty (20) days have elapsed since service on
7 defendants of the Writ of Garnishment and garnishee defendants' answer thereto, it is HEREBY
8 ORDERED, ADJUDGED AND DECREED that:

9 1. The Clerk of Court is directed to enter judgment against garnishee defendant in the
10 amount of \$20,747.13, such funds to be first applied in satisfaction of the costs and fees taxable
11 herein;

12 2. Upon payment by garnishee defendant of the aforementioned sum to the registry of
13 this Court, the garnishee defendant shall be discharged from this action. Upon receipt of said
14 sum, the Clerk of the Court shall thereupon enter a full satisfaction of the judgment against
15 garnishee defendant;


16 3. Plaintiff shall have judgment against the defendants, 123 DIRECT LTD d/b/a 123
17 DIRECT USA dba 123 HEALTHSHOP; JOSE MANUEL-MENDEZ NAVARRO; JEREMY
18 MICHAEL ROURKE-PILOTT, for attorneys fees and costs in the sum of \$404, said sum to be
19 added to plaintiff's prior judgment against defendants;

20 4. Upon receipt of the aforementioned payment from garnishee defendant, the Clerk is
21 authorized and directed to draw a check on the funds on deposit in the registry of this Court in
22 the principal amount of \$20,747.13, plus all accrued interest, minus any statutory user fees,

1 payable to Everidis Health Sciences, LLC, c/o Schweet Linde & Coulson, PLLC, 575 S.
2 Michigan St., Seattle, WA 98108.

3 5. Upon receipt of said sum, plaintiff's attorney shall cause an appropriate satisfaction of
4 judgment to be filed as to the principal defendants.
