Continuing Garnishee Order

19 A Writ of Continuing Garnishment, directed to Garnishee, Buffalo Wild
20 Wings, has been duly issued and served upon the Garnishee. Pursuant to the
21 Writ, Garnishee Buffalo Wild Wings filed a proper Answer on September 15,
22 2017, stating that at the time of the service of the Writ, Defendant/Judgment
23 Debtor Deshon Michael Parker, was an active employee who was paid bi-
24 weekly.

1 After notification of the garnishment proceeding was mailed to the
2 parties on or about July 28, 2017, the Defendant/Judgment Debtor has not
3 requested a hearing to determine exempt property as of this date.
4

5 IT IS THEREFORE ORDERED as follows:

6 That the Garnishee, Buffalo Wild Wings, shall pay to the United States
7 District Court for the Western District of Washington, the non-exempt
8 earnings payable to Defendant/Judgment Debtor Deshon Michael Parker,
9 upon each period of time when Defendant/Judgment Debtor Parker is entitled
10 to receive such funds, and shall continue said payments, if any, until
11 Defendant/Judgment Debtor Parker's debt is paid in full or until
12 Defendant/Judgment Debtor is no longer an active employee of Garnishee
13 and the Garnishee no longer has possession, custody, or control of any funds
14 due and owing to the Defendant/Judgment Debtor or until further order of
15 this Court. This includes all monies required to be previously withheld by the
16 Garnishee, in accordance with the Writ of Continuing Garnishment;


19 That such payments shall be applied to Defendant/Judgment Debtor
20 Parker's outstanding restitution obligation, by the United States District
21 Court for the Western District of Washington; and

23 That the payments shall be made out to the United States District
24 Court, Western District of Washington, referencing Case Nos. 2:17-MC-
25 00078-RSL and 2:98-CR-00725-TSZ-1, and to deliver such payment either
26 personally or by First Class Mail to:
