ORDER DIRECTING ENTRY OF  
JUDGMENT ON GARNISHEE ANSWER – 1

1           IT APPEARING THAT Garnishee Defendant was indebted to Defendant Port  
2 Machine Works, Inc. in the nonexempt amount of \$10,522.45 at the time the Writ of  
3 Garnishment was issued, THAT Plaintiffs have a judgment unsatisfied against Defendant in  
4 the amount of \$10,366.45, THAT Plaintiff has incurred recoverable costs and attorney fees of  
5 \$156.00 in this garnishment action, THAT Plaintiff attempted service of the Writ of  
6 Garnishment on Defendant by Certified Mail to the address on file with the Washington  
7 Secretary of State and it was returned as unclaimed, and THAT more than twenty days have  
8 elapsed since the Garnishee Defendant filed its Answer; now, therefore, it is hereby

9           ORDERED, ADJUDGED, AND DECREED that:

10           1. Plaintiff is awarded judgment against Defendant in the amount of \$156.00 for  
11 recoverable costs;

12           2. Plaintiff is awarded judgment against Defendant Garnishee, KeyBank National  
13 Association, in the amount of \$10,522.45;

14           3. Garnishee Defendant shall pay its judgment amount to the Registry of the Court.  
15 Upon payment by the Garnishee Defendant, said Garnishee Defendant shall be discharged  
16 from this action and the Clerk of Court shall enter full satisfaction of the judgment against  
17 Garnishee Defendant.

18           4. Upon receipt of the aforementioned payment from the Garnishee Defendant, the  
19 Clerk of Court is authorized and directed to draw a check on the funds on deposit in the  
20 registry of the court in the principal amount of \$10,522.45, plus all accrued interest, minus  
21 any statutory user fees, payable to the Board of Trustees of the Western Metal Industry

1      Pension Fund and shall mail or deliver the check to McKenzie Rothwell Barlow & Coughran,  
2      P.S., ATTN: Noelle E. Dwarzski, 1325 Fourth Ave., Suite 910, Seattle, WA 98101-2573; and  
3                5. Upon receipt of said sum, Plaintiff's attorney shall cause an appropriate satisfaction  
4      of judgment to be filed as to the principal Defendant.
