**[Proposed] Agreed Continuing
Garnishee Order**

A Writ of Continuing Garnishment directed to Garnishee, Petco, has been duly issued and served upon the Garnishee. Pursuant to the Writ, Garnishee Petco, filed its Answer on December 26, 2017, stating that at the time of the service of the Writ, Defendant/Judgment Debtor Lara G. Oneschak (Ms. Oneschak) was an active employee who was paid semi-monthly.

1 After notification of the garnishment proceeding was mailed to the parties
2 on or about September 19, 2017, the Defendant/Judgment Debtor has not
3 requested a hearing to determine exempt property as of this date. On January
4 19, 2018, the United States filed an Agreed Motion to Issue Continuing
5 Garnishee Order, stating that it had agreed with Ms. Oneschak to request a
6 reduced garnishment rate of 10 percent of her disposable earnings at Petco.
7 The United States attached a Proposed Agreed Continuing Garnishee Order to
8 that effect, jointly presented with Ms. Oneschak and bearing her signature.
9

10 IT IS THEREFORE ORDERED as follows:

11 That Garnishee, Petco, shall pay to the United States District Court for
12 the Western District of Washington, all non-exempt earnings payable to Ms.
13 Oneschak, that it has previously withheld pursuant to the Writ of Garnishment;

15 That from this date forward, Petco shall withhold and pay to the United
16 States District Court for the Western District of Washington, 10 percent of the
17 disposable earnings payable to Ms. Oneschak upon each period of time when
18 Ms. Oneschak is entitled to receive such funds, and shall continue such
19 payments, if any, until Ms. Oneschak's debt is paid in full or until she is no
20 longer an active employee of Garnishee and the Garnishee no longer has
21 possession, custody, or control of any funds due and owing to Ms. Oneschak,
22 or until further order of this Court;
