STIPULATION

2. On January 11, 2019, the Court entered an order granting the parties' stipulated request to permit certain depositions to take place after the discovery cutoff.

2 currently located in China, the parties have further agreed to take Defendant Zhenyao Yang's
3 deposition during the week of February 11, 2019.

5 leave—to take this deposition after the February 3, 2018 discovery cutoff. This stipulation will
6 not require the amendment or postponement of any other case deadlines, including the
7 dispositive motions deadline or the trial date.
