ORDER DENYING PLAINTIFF'S  
MOTION FOR RECONSIDERATION

16 The instant matter comes before the Court on Plaintiff Rita Cagliostro's Motion for  
17 Reconsideration. Dkt. #53. The Court has determined that it can rule on this Motion without  
18 responsive briefing.

19 "Motions for reconsideration are disfavored." LCR 7(h)(1). "The court will ordinarily  
20 deny such motions in the absence of a showing of manifest error in the prior ruling or a  
21 showing of new facts or legal authority which could not have been brought to its attention  
22 earlier with reasonable diligence." *Id.* Motions for reconsideration "shall be filed within  
23 fourteen days after the order to which it relates is filed." LCR 7(h)(2). "Failure to comply with  
24 this subsection may be grounds for denial of the motion." *Id.*

27 The Court interprets Plaintiff's filing as a Motion for Reconsideration because Plaintiff  
28 titles her Motion as such and repeatedly asks the Court to "reconsider" its prior Order

1 dismissing this case dated August 10, 2018. Dkt. #53. The Court finds that Plaintiff's Motion  
2 is untimely and is properly dismissed on that ground alone. Plaintiff asks for reconsideration  
3 on the Court's August 10, 2018, Order, yet has filed this Motion on September 7, 2018, 28 days  
4 later. Furthermore, it appears from the record that Plaintiff has already appealed the Court's  
5 Order, rendering this Motion duplicative and unnecessary.

7 Having reviewed the relevant briefing and the remainder of the record, the Court hereby  
8 finds and ORDERS that Plaintiff Rita Cagliostro's Motion for Reconsideration, Dkt. #53, is  
9 DENIED. The Clerk shall send a copy of this Order to Plaintiff at 212 ALASKAN WAY S.  
10 #205 SEATTLE, WA 98104.
