2	2.	The Court finds that defendant Quality Finish, Inc. is liable to the Carpenters
3		Trusts under the provisions of the collective bargaining and trust agreements that govern the relationship in this matter;
4	3.	The Court finds that defendant Quality Finish, Inc. is liable to the Carpenters
5		Trusts for \$18,672.77, as set forth in the February 6, 2017 audit, consisting of \$12,507.26 in fringe benefit contributions for the period January 1, 2015 through March 31, 2016, \$2,164.08 in liquidated damages, \$1,012.50 in audit
