STIPULATED MOTION AND
ORDER TO MODIFY
SCHEDULING ORDER

Pursuant to Fed. R. Civ. P. 6(b)(1), the parties move for an order modifying the scheduling order to extend all existing deadlines by two months. *See* Dkt. #18.
