**STIPULATION AND ORDER
EXTENDING TIME TO RESPOND TO
COMPLAINT**

I. STIPULATION

The current deadline for defendants First Impression Interactive, Inc., Jeffrey Giles, and Dale Brown to respond to plaintiff's Complaint is June 7, 2019. *See* Dkt. 12. Defendants First Impression Interactive, Inc., Jeffrey Giles, and Dale Brown currently intend to respond by a motion to dismiss for lack of personal jurisdiction and improper venue, or, in the alternative, to transfer venue.
