**Continuing Garnishment Order**

19 A Writ of Continuing Garnishment, directed to Garnishee Fidelity  
20 Investments, has been duly issued and served upon the Garnishee. Pursuant  
21 to the Writ, Garnishee Fidelity Investments filed its Answer on January 23,  
22 2020, stating that at the time of the service of the Writ, Garnishee had in its  
23 possession, custody, or control a Transgroup 401(k) Profit Sharing Plan and  
24 Trust, valued at \$49,693.32, as of January 17, 2020, in which  
25 Defendant/Judgment Debtor Toni Andersson maintains an interest.

1 After notification that the garnishment proceeding was mailed to the  
2 Garnishee and Defendant/Judgment Debtor Andersson on or about  
3 December 18, 2019, Mr. Andersson has not requested a hearing to determine  
4 exempt property as of this date.  
5

6 IT IS THEREFORE ORDERED as follows:

7 That the Garnishee, Fidelity Investments, shall pay to the United States  
8 District Court for the Western District of Washington, the entire amount (less  
9 federal tax withholdings paid to the Internal Revenue Service, if any) of non-  
10 exempt property from any and all accounts in the Garnishee's possession,  
11 custody, or control, in which the Defendant/Judgment Debtor maintains an  
12 interest;  
13

14 That such payments shall be applied to Defendant/Judgment Debtor  
15 Toni Andersson's outstanding restitution debt, by the United States District  
16 Court for the Western District of Washington; and

18 That the payments shall be made out to the United States District  
19 Court, Western District of Washington, referencing Case Nos. 2:16-CR-0128-1  
20 and 2:19-MC-00166-RSL, and delivered either personally or by First Class  
21 Mail to:
