While the public has a common law right to inspect and copy public 3 records, including those from judicial proceedings, these rights are not absolute. They must yield when (1) sealing a document serves a compelling interest, (2) that is substantially likely to be 4 harmed if the document is not sealed, and (3) there are no less restrictive alternative means for 5 protecting the interest. See United States v. Doe, 870 F.3d 991, 998 (9th Cir. 2017).
