November 13, 2023

1 Pursuant to Western District of Washington Local Rules 7(d)(1) and 10(g), Plaintiffs Cindy
2 Codoni, Michelle Geer, Horace Cathcart, Amy France, and Tamara Chakos (“Plaintiffs”) and
3 Defendants Alaska Air Group, Delta Airlines, Inc. (“Airlines”), and Port of Seattle (collectively,
4 “Defendants”) stipulate and move as follows:

5 WHEREAS, on June 27, 2023, this Court ordered Plaintiffs to file a Second Amended
6 Complaint on or before August 11, 2023, and ordered the parties to confer in good faith to set a
7 deadline for Defendants to respond to the Second Amended Complaint (ECF No. 41);

8 WHEREAS, on August 11, 2023, Plaintiffs filed their Second Amended Class Action
9 Complaint (ECF No. 43);

10 WHEREAS, on September 18, 2023, this Court ordered Defendants to file their Rule 12
11 motions in response to the Second Amended Complaint on or before October 27, 2023, and
12 ordered the parties to confer in good faith to set a deadline for Plaintiffs’ opposition to Defendants’
13 motions and Defendants’ replies in support thereof (ECF No. 45); and

14 WHEREAS, the parties have conferred in good faith regarding an appropriate briefing
15 schedule and agree that Plaintiffs’ deadline to file their opposition to Defendants’ motions to
16 dismiss is December 22, 2023, and Defendants’ deadline to file their replies in support of their
17 motions is February 16, 2024;

18 **THEREFORE, IT IS STIPULATED AND AGREED** among the Parties, subject to the
19 Court’s approval, that:

20 1. Plaintiffs shall file their opposition(s) to Defendants’ motions to dismiss Plaintiffs’
21 Second Amended Complaint on or before December 22, 2023.

22 2. Defendants shall file their replies in support of their motions to dismiss Plaintiffs’
23 Second Amended Complaint on or before February 16, 2024.

24 3. Nothing in this stipulated order shall alter any other deadlines in the case, including
25 those deadlines included in this Court’s September 18, 2023, order (ECF No. 45).
