I. STIPULATION

The parties to this action, by and through their respective attorneys of record, hereby stipulate and agree that documents marked “CONFIDENTIAL” shall be filed under sealed pursuant to the Court’s Order of June 1, 2010 and consistent with Local Civil Rule 5(g). (Order Granting Plaintiff’s Motion to Compel Production of Documents Responsive to Requests for Production Nos. 33 to 36 (Dkt. No. 91)). The documents marked “CONFIDENTIAL” that were produced by Defendants pursuant to the Court’s Order contain highly sensitive information concerning personnel information of non-parties. (*See* Declaration of Sher Kung ¶ 2). The

information is relevant to this case, but because it involves non-parties and personnel information, parties to the litigation agree to maintain confidentiality. *Id.* The presumption in favor of public access is overcome by the highly sensitive nature of the information contained in these documents. *Id.*


