20 **ORDER**


21 This matter having come before the Court on the foregoing stipulation of Plaintiff and the
22 Scheckenbach Defendants, it is hereby ordered that:

- 23 1. The Preliminary Injunction entered on December 14, 2010 (Dkt #435), as
24 amended thereafter (*see* Dkt #s 442, 449 and 455), is lifted and released
25 immediately and all parties governed by the injunction, as amended, are
26 discharged from further compliance with its terms.
2. Furthermore, (a) all bank and financial institution accounts still frozen are
immediately unfrozen and (b) the Scheckenbach Defendants are immediately

1 released from all restrictions on the use of any assets or monies covered by the
2 injunction, as amended.

3 3. The Scheckenbach Defendants are authorized to provide a copy of this Order,
4 promptly following its entry to any bank or institution previously bound by the
5 Preliminary Injunction, including without limitation: Ameritrade (Gillette,
6 #1149), Frontier Bank (Scheckenbach, #6353), ING (Gillette, #4457), KeyBank
7 (RavenSky, #5850; Ilcervello Properties, #4887); Gillette, #5924), Northwestern
8 Mutual Insurance (Gillette #s 2701 and 4191; Scheckenbach #6488), Pacific
9 Continental Bank (Breakthrough Nutrition, #3585; Gillette, #9913), Prudential
10 (Scheckenbach, #7756; Gillette, #7734), Schwab (Scheckenbach #5755) and
11 Wells Fargo Bank (Gillette, #s 3982 and 7777) and shall, contemporaneously
12 therewith, provide a copy of the communication to plaintiff. Upon request of any
13 bank or institution, or upon request of the Scheckenbach Defendants, plaintiff will
14 promptly confirm to the bank or institution the entry of this Order to those persons,
15 and contemporaneously, provide a copy of such communication to the
16 Scheckenbach Defendants.
