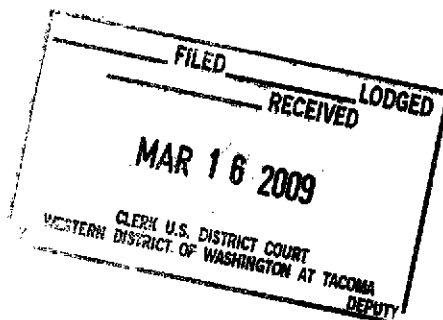

I. STIPULATION


