
ORDER

13 This 28 U.S.C. § 2254 petition has been assigned to the undersigned Magistrate Judge.
14 Petitioner has filed two motions for appointment of counsel. (Dkt. #1 and 5).

15 There is no right to have counsel appointed in cases brought under 28 U.S.C. § 2254 unless
16 an evidentiary hearing is required, because the action is civil, not criminal, in nature. See Terravona
17 v. Kincheloe, 852 F.2d 424, 429 (9th Cir. 1988); Brown v. Vasquez, 952 F.2d 1164, 1168 (9th Cir.
18 1992); and Rule 8(c) of the Rules Governing Section 2254 Cases in the United States District Courts.
19 An evidentiary hearing has not been granted in this case. Further, the claims in the petition are
20 adequately set forth and articulated. Petitioner's motions for appointment of counsel, (Dkt. # 1 and
21 5), are therefore **DENIED**.
