NOW THEREFORE, IT IS

ORDERED that the preferred marine mortgage on the P/C M T
POCKETS, Official Number 537196, her engines, tackle, apparel, furniture and
equipment, in favor of Washington State Employees Credit Union, is foreclosed; and
it is further

ORDERED that Washington State Employees Credit Union shall have
judgment against the P/C M T POCKETS, Official Number 537196, her engines,
tackle, apparel, furniture and equipment *In Rem* for \$105,844.84, plus interest at
the rate of \$23.92 per day from April 14, 2010 through the date of entry of this
