15	This matter comes before the Court on Plaintiff James Bigelow's ("Bigelow")	
16	motion for reconsideration (Dkt. 93). The Court has considered the pleading filed in	
17	support of the motion and the remainder of the file and hereby renotes the motion for the	
18	reasons stated herein.	
	I. PROCEDURAL HISTORY	
19	On February 23, 2015, Bigelow filed an amended complaint against Defendants	
20	Green Tree Servicing, LLC, Mortgage Electronic Registration Systems, Inc., Renee	
21	Parker, and Wright, Finlay & Zak, LLP's ("Defendants"). Dkt. 44. On March 13, 2015,

1 Renee Parker and Wright, Finlay & Zak, LLP ("Attorney Defendants") moved to strike 2 Bigelow's complaint in its entirety under Washington's Anti-SLAPP statute, RCW 3 4.24.525. Dkt. 60. On June 1, 2015, the Court denied the motion. Dkt. 92. On June 15, 2015, Attorney Defendants filed a motion for reconsideration. Dkt. 93. On July 16, 4 5 2015, the Court granted the motion. Dkt. 99. 6 On August 4, 2015, Bigelow filed a motion for reconsideration based on the recent 7 ruling by the Washington Supreme Court that RCW 4.24.525 violates the Washington 8 State Constitution. See Davis v. Cox, 351 P.3d 862, 864 (Wash. 2015). 9 **II. DISCUSSION** 10 In light of Washington's Anti-SLAPP statute being declared unconstitutional, the 11 Court will set a briefing schedule pursuant to the local rules. Local Rules, W.D. Wash. 12 LCR 7(h)(3). The Attorney Defendants may file a response no later than August 18, 13 2015. Bigelow may file a reply no later than August 21, 2015. The Clerk shall renote the 14 motion for reconsideration on the Court's August 21, 2015 calendar. 15 **III.
