2 Court on June 24, 2015 (Dkt #5). After hearing on the order to show cause, the Court has
3 determined that cause exists to extend the temporary restraining order for a period of fourteen
4 (14) days. Therefore, it is hereby ORDERED:

5 1. The temporary restraining order (Dkt #5) shall remain in full force and effect and
6 the temporary restraining order is hereby extended for a period of fourteen (14) days;


7 2. This Order is entered this 26th day of June, 2015, at 11:45 Am., and is effective
