ORDER DENYING MOTION TO
COMPEL

15 The District Court has referred this 42 U.S.C. § 1983 action to United States Magistrate
16 Judge David W. Christel. Presently before the Court is Plaintiff Donald Stockmyer's Motion
17 requesting the Court compel discovery. Dkt. 42.¹ The Court concludes Plaintiff failed to comply
18 with Rule 37 and failed to timely file the Motion. Accordingly, the Motion (Dkt.42) is denied.

19 Pursuant to Federal Rule of Civil Procedure 37(a)(1):

20 . . . On notice to other parties and all affected persons, a party may move for an
21 order compelling disclosure or discovery. The motion must include a certification
22 that the movant has in good faith conferred or attempted to confer with the person

1 or party failing to make disclosure or discovery in an effort to obtain it without
2 court action.

3 *See also* Dkt. 26; LCR 37(a)(1). Here, Plaintiff is moving for a Court order compelling
4 Defendants to answer interrogatories and produce documents. Dkt. 42. Plaintiff, however, failed
5 to certify he conferred or attempted to confer with Defendants' counsel regarding the requested
6 discovery. *See id.* Therefore, Plaintiff has not complied with Rule 37.

7 Further, Plaintiff was required to file any motion to compel no later than May 4, 2017.
8 *See* Dkt. 26, p. 6. Plaintiff filed his Motion on June 13, 2017, which is more than a month after
9 the deadline to file a motion to compel expired. Therefore, Plaintiff's Motion is untimely.

10 As Plaintiff has not complied with Rule 37 and as he did not timely file the Motion, the
11 Motion (Dkt. 42) is denied.
