ORDER ON STIPULATED  
MOTION FOR EQUAL ACCESS  
TO JUSTICE ACT FEES

17 This Court has jurisdiction pursuant to 28 U.S.C. § 636(c), Fed. R. Civ. P. 73 and Local  
18 Magistrate Judge Rule MJR 13. (*See also* Notice of Initial Assignment to a U.S. Magistrate  
19 Judge and Consent Form, Dkt. 5; Consent to Proceed Before a United States Magistrate Judge,  
20 Dkt. 6). This matter is before the Court on plaintiff's Stipulated Motion for Equal Access to  
21 Justice Act Fees. (*See* Dkt. 16).

22 Based on the Equal Access to Justice Act, 28 U.S.C. § 2412, ("EAJA"), the Stipulation of  
23 the parties (*see* Dkt. 16), and the relevant record, it is hereby ORDERED that EAJA attorney's  
24

1 fees of \$5,028.95, shall be awarded to plaintiff pursuant to the EAJA and consistent with *Astrue*  
2 *v. Ratliff*, 130 S.Ct. 2521, 2524, 2010 U.S. LEXIS 4763 at \*\*\*6-\*\*\*7 (2010).

3 The Acting Commissioner shall contact the Department of Treasury after the Order for  
4 EAJA fees is entered to determine if the EAJA fees are subject to any offset. If it is determined  
5 that plaintiff's EAJA fees are not subject to any offset allowed pursuant to the Department of the  
6 Treasury's Offset Program, then the check for EAJA fees shall be made payable to Dellert Baird  
7 Law Offices, PLLC, based on plaintiff's assignment of these amounts to plaintiff's attorney (*see*  
8 Dkt. 16). If there is an offset, the remainder shall be made payable to plaintiff, based on the  
9 practice of the Department of the Treasury (*see, e.g.*, Case No. 2:15-cv-122, Dkt. 22, p. 4). Any  
10 check for EAJA fees shall be mailed to plaintiff's counsel, Dellert Baird Law Offices, PLLC,  
11 P.O. Box 97301, Lakewood, WA, 98497.
