REPORT AND RECOMMENDATION

15 Plaintiff brought this action to seek judicial review of the denial of her application for
16 disability benefits by the Commissioner of the Social Security Administration. Dkt. 5. The
17 parties have stipulated that this case should be reversed and remanded for further administrative
18 proceedings pursuant to sentence four of 42 U.S.C. § 405(g). Dkt. 26.

19 Based on the stipulation of the parties, the Court recommends that this case be
20 REVERSED and REMANDED for further administrative proceedings before an Administrative
21 Law Judge (“ALJ”), including a de novo hearing. On remand, the ALJ shall provide plaintiff
22 with an opportunity for a hearing; reevaluate the medical evidence of record, including reviewing
23 the record for any chronic problems in plaintiff’s vision, memory and mood; reevaluate how the
24 combination of claimant’s impairments affect her ability to maintain concentration, persistence,

1 or pace; reassess her residual functional capacity; reevaluate claimant's past work and determine
2 whether it meets the requirements of recency, income, and duration, in order to be considered
3 past relevant work (20 C.F.R. § 416.965(a)); if applicable, evaluate whether the claimant could
4 still perform past relevant work pursuant to 20 C.F.R. § 416.968 and Social Security Ruling 82-
5 41; and determine whether she acquired skills from past relevant work that can be transferred to
6 other work in the national economy (20 C.F.R. §§ 416.966, 416.968), with little or no
7 adjustment; obtaining vocational expert testimony about the transferability of skills and any
8 vocational adjustment required, as necessary; obtaining other supplemental vocational evidence,
9 as necessary; and issue a new decision.

10 Because the parties have stipulated that the case be remanded as set forth above, the
11 Court recommends that United States District Judge Benjamin H. Settle immediately approve
12 this Report and Recommendation. The Clerk should note the matter for **June 13, 2017** as ready
13 for Judge Settle's consideration. A proposed order accompanies this Report and
14 Recommendation.
