ORDER FOR SERVICE AND
ANSWER, § 2254 PETITION

14 This is a federal habeas action filed under 28 U.S.C. § 2254. Petitioner, who is
15 represented by counsel in this matter, is currently incarcerated at the Stafford Creek Corrections
16 Center and is subject to the Court's Mandatory Electronic E-Filing Pilot Project pursuant to
17 General Order 02-15. The Court, having reviewed petitioner's federal habeas petition, hereby
18 finds and **ORDERS** as follows:

19 (1) The Clerk shall arrange for service by e-mail upon respondent and upon the
20 Attorney General of the State of Washington, of copies of the petition, of all documents in
21 support thereof, and of this Order.

22 (2) Within *forty-five (45) days* after such service, respondent(s) shall file and serve an
23 answer in accordance with Rule 5 of the Rules Governing Section 2254 Cases in United States

§ 2254 PETITION - 1

1 District Courts. As part of such answer, respondent(s) shall state whether petitioner has
2 exhausted available state remedies and whether an evidentiary hearing is necessary.
3 Respondent(s) shall not file a dispositive motion in place of an answer without first showing
4 cause as to why an answer is inadequate. Respondent(s) shall file the answer with the Clerk of
5 the Court and serve a copy of the answer on petitioner.

6 (3) The answer will be treated in accordance with LCR 7. Accordingly, on the face
7 of the answer, respondent(s) shall note it for consideration on the fourth Friday after filing.
8 Petitioner may file and serve a response not later than the Monday immediately preceding the
9 Friday designated for consideration of the matter, and respondent(s) may file and serve a reply
10 not later than the Friday designated for consideration of the matter.

11 (4) Filing by Parties, Generally

12 All attorneys admitted to practice before this Court are required to file documents
13 electronically via the Court's CM/ECF system. All filings must indicate in the upper right hand
14 corner the name of the magistrate judge to whom the document is directed.

15 Any document filed with the Court must be accompanied by proof that it has been
16 electronically served upon all parties that have entered a notice of appearance in the underlying
17 matter.

18 (5) Motions

19 Any request or court action shall be set forth in a motion, properly filed and served.
20 Pursuant to LCR 7(b), any argument being offered in support of a motion shall be submitted as a
21 part of the motion itself and not in a separate document. The motion shall include in its caption
22 (immediately below the title of the motion) a designation of the date the motion is to be noted for
23 consideration on the Court's motion calendar.

1 (6) Direct Communications with District Judge or Magistrate Judge

2 No direct communication is to take place with the District Judge or Magistrate Judge with
3 regard to this case. All relevant information and papers are to be directed to the Clerk.
