Petitioner is currently 15 incarcerated at the Monroe Correctional Complex and is subject to the Court's Electronic E-Filing Program pursuant to General Orders 02-15 and 06-16. The Court, having reviewed 16 petitioner's federal habeas petition, hereby finds and **ORDERS** as follows: 17 18 (1) The Clerk shall arrange for service by e-mail upon respondent and upon the 19 Attorney General of the State of Washington, copies of the petition, all documents in support 20 thereof, and this Order. The Clerk shall also direct a copy of this Order and of the Court's pro se 21 instruction sheet to petitioner. 22 (2) Within *forty-five* (45) days after such service, respondent(s) shall file and serve an 23 answer in accordance with Rule 5 of the Rules Governing Section 2254 Cases in United States 24

District Courts. As part of such answer, respondent(s) shall state whether petitioner has exhausted available state remedies and whether an evidentiary hearing is necessary. Respondent(s) shall not file a dispositive motion in place of an answer without first showing 3 cause as to why an answer is inadequate. Respondent(s) shall file the answer with the Clerk of 5 the Court and serve a copy of the answer on petitioner. The answer will be treated in accordance with LCR 7. Accordingly, on the face 6 (3)of the answer, respondent(s) shall note it for consideration on the fourth Friday after filing. Petitioner may file and serve a response not later than the Monday immediately preceding the 8 Friday designated for consideration of the matter, and respondent(s) may file and serve a reply 10 not later than the Friday designated for consideration of the matter. 11 (4) Filing by Parties, Generally 12 All attorneys admitted to practice before this Court are required to file documents electronically via the Court's CM/ECF system. Petitioner shall file all documents electronically. 13 14 All filings must indicate in the upper right hand corner the name of the magistrate judge to whom 15 the document is directed. 16 Any document filed with the Court must be accompanied by proof that it has been served 17 upon all parties that have entered a notice of appearance in the underlying matter. Petitioner 18 shall indicate the date the document is submitted for e-filing as the date of service. 19 (5) Motions 20 Any request for court action shall be set forth in a motion, properly filed and served. 21 Pursuant to LCR 7(b), any argument being offered in support of a motion shall be submitted as a 22 part of the motion itself and not in a separate document. The motion shall include in its caption 23 (immediately below the title of the motion) a designation of the date the motion is to be noted for

consideration on the Court's motion calendar. Direct Communications with District Judge or Magistrate Judge (6) No direct communication is to take place with the District Judge or Magistrate Judge with regard to this case.
