1 IT IS THEREFORE ORDERED as follows:

2 That the Garnishee, United Rentals, shall pay to the United States
3 District Court for the District of Montana, the non-exempt earnings payable to
4 Defendant/Judgment Debtor Steven Ritchard Scott, upon each period of time
5 when Defendant/Judgment Debtor Scott is entitled to receive such funds, and
6 shall continue said payments, if any, until Defendant/Judgment Debtor
7 Scott's debt is paid in full or until Defendant/Judgment Debtor is no longer
8 an active employee of Garnishee and the Garnishee no longer has possession,
9 custody or control of any funds due and owing to the Defendant/Judgment
10 Debtor or until further order of this Court. This includes all monies
11 previously withheld by the Garnishee, in accordance with the Writ of
12 Continuing Garnishment;

13 That such payments shall be applied to Defendant/Judgment Debtor
14 Scott's outstanding obligation, by the United States District Court for the
15 District of Montana; and

17 Court, District of Montana, referencing Case No. CR-07-134-GF-SHE-01 and
