ORDER ON REVIEW OF
REFUSAL TO RECUSE

13 This matter comes before the Court on Plaintiff's motion to recuse U.S. District Judge
14 Ronald B. Leighton. Dkt. #5.¹ Upon review of the motion, Judge Leighton declined to recuse
15 himself. Dkt. #12. In accordance with the Local Rules of this District, Plaintiff's motion was
16 referred to the Undersigned for a review of Judge Leighton's refusal to recuse. LCR 3(e).

17 Plaintiff bases her motion to recuse on two grounds: (1) that Judge Leighton is "mentioned
18 as an [*sic*] 'MOST HOSTILE WITNESS' in EEO COMPLAINT NO. 16-4523A-02816 A CLASS
19 ACTION CASE IN COURT" (dkt. #5 at 1; emphasis in original), and (2) a series of unfavorable
20 rulings that Judge Leighton has issued in her cases, ranging from refusal to grant motions to
21 proceed *in forma pauperis* to dismissal. *Id.* at 2-6.

23 ¹ Plaintiff has filed an identical motion in the following cases: C17-5273RBL, C17-5366RBL,
24 C17-5367RBL, C17-5368RBL, and C17-5426RBL; in each instance the presiding judge has
declined to recuse voluntarily.

1 Pursuant to 28 U.S.C. § 455(a), a judge of the United States shall disqualify himself in any
2 proceeding in which his impartiality “might reasonably be questioned.” Federal judges also shall
3 disqualify themselves in circumstances where they have a personal bias or prejudice concerning a
4 party or personal knowledge of disputed evidentiary facts concerning the proceeding. 28 U.S.C.
5 § 455(b)(1).

6 Under both 28 U.S.C. §144 and 28 U.S.C. § 455, recusal of a federal judge is appropriate
7 if “a reasonable person with knowledge of all the facts would conclude that the judge’s impartiality
8 might reasonably be questioned.” *Yagman v. Republic Insurance*, 987 F.2d 622, 626 (9th
9 Cir.1993). This is an objective inquiry concerned with whether there is the appearance of bias, not
10 whether there is bias in fact. *Preston v. United States*, 923 F.2d 731, 734 (9th Cir.1992); *United*
11 *States v. Conforte*, 624 F.2d 869, 881 (9th Cir.1980). In *Liteky v. United States*, 510 U.S. 540
12 (1994), the United States Supreme Court further explained the narrow basis for recusal:

13 [J]udicial rulings alone almost never constitute a valid basis for a bias or
14 partiality motion. . . . [O]pinions formed by the judge on the basis of facts
15 introduced or events occurring in the course of the current proceedings, or of
16 prior proceedings, do not constitute a basis for a bias or partiality motion
17 unless they display a deep seated favoritism or antagonism that would make
18 fair judgment impossible. Thus, judicial remarks during the course of a trial
19 that are critical or disapproving of, or even hostile to, counsel, the parties, or
20 their cases, ordinarily do not support a bias or partiality challenge.

21 *Id.* at 555.

22 Plaintiff cites no other reasons or evidence in support of her position than Judge Leighton’s
23 having been named as a “hostile witness” in a legal action in California and her dissatisfaction
24 with his prior rulings. This is insufficient to form the basis of a valid request for recusal.²

25 ² In his Order Denying Motion to Recuse, Judge Leighton makes reference to a third allegation
26 concerning his alleged relationship with “Attorney Alison Louise McKay” which apparently

1 In the first place, a judge's conduct in the context of this or previous judicial proceedings
2 does not constitute the requisite bias under 28 U.S.C. § 144 or § 455 if it is prompted solely by
3 information that the judge received in the context of the performance of his duties. Bias is almost
4 never established simply because the judge issued adverse rulings against a party.

5 In order to overcome this presumption, Plaintiff would have to show that facts outside the
6 record influenced decisions or that the judge's rulings were so irrational that they must be the result
7 of prejudice. Plaintiff does not allege any facts outside the record that improperly influenced the
8 decisions in her matters. Outside of her general, conclusory accusations, Plaintiff cites to no
9 specific rulings that are either outlandish or irrational or in any way give rise to an inference of
10 bias.

11 In the second place, Plaintiff cites to no authority (and this Court knows of none) which
12 holds that naming a judge as a witness or party in another lawsuit entitles a complainant to have
13 that judge removed from pending litigation. If that were the case, all a disgruntled litigant would
14 have to do to rid himself or herself of a judge presiding over their case would be to name that judge
15 as a witness or defendant. This is not the state of the law.

16 The Court finds no evidence upon which to reasonably question Judge Leighton's
17 impartiality and AFFIRMS his denial of Plaintiff's request that he recuse himself.

18 The Clerk SHALL provide copies of this Order to Plaintiff and to all counsel of record.
