

1 attorney. Pursuant to *Astrue v. Ratliff*, the ability to honor the assignment will depend on
2 whether the EAJA fees and expenses are subject to any offset allowed under the Treasury
3 Offset Program. The Commissioner agrees to contact the Department of Treasury after
4 the order for EAJA fees and expenses is entered to determine whether the EAJA fees and
5 expenses are subject to any offset. If the EAJA fees and expenses are not subject to any
6 offset, the EAJA attorney's fees and expenses will be paid directly to plaintiff's attorney
7 Eitan Kassel Yanich, either by direct deposit or by check payable to him and mailed to
8 his address.
