16 **STIPULATED MOTION**

17 Plaintiff Lumentum Operations LLC ("Lumentum") and Defendants nLIGHT, Inc.
18 ("nLIGHT"), Dahv Kliner ("Kliner"), and Roger L. Farrow ("Farrow") (collectively, the
19 "Parties"), hereby respectfully submit this Second Stipulated Motion to Extend the Time for
