5	authority under, and for the limited purposes set forth in, RCW 49.17.070. L&I's claim for	
6	access under HB 1470 Sec. 3, codified at RCW 70.395.070, is dismissed without prejudice,	
7	and its other claims are dismissed with prejudice. Dismissal of Plaintiff's claim for	
8	contempt from the January 30, 2024 complaint shall not mean that Plaintiff cannot pursue	
9	contempt if there is a violation of this permanent injunction. Each side will bear its own	
10	costs and fees.	
11	This Court shall retain jurisdiction to enforce or modify the injunction.
