1 additional 14 days to recover from her worsened medical condition and properly prepare her
2 reply. The parties have conferred, Plaintiff provided a medical record, and the Defendants
3 have graciously agreed to the stipulated request for the extension. Plaintiff proposes to extend
4 her deadline to November 11, 2024, with the motion being noted on the same date. Plaintiff
5 also agrees to limit her reply brief to 2,100 words, pursuant to LCR 7(e)(4).

6 Pursuant to Local Civil Rule 7(j), the Court may, for good cause, extend the deadlines for
7 filings. Plaintiff's request is based on medical/health issues, which have limited her ability to
8 meet the original filing deadline. Defendants have agreed to the extension, and no party will
9 be prejudiced by this short delay.
