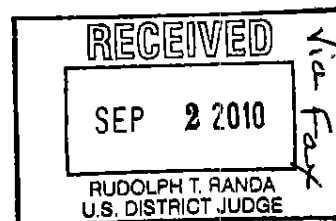

Dear Honorable Judge Randa:

I am writing to respectfully request assistance to facilitate problems relating to the receipt of court documentation. Documentation from the court and the parties involved in the above captioned proceeding take approximately 2 weeks or more to reach my destination and I respectfully submit that this duration of time in transit negatively affects the defendants' and counterclaim plaintiffs' ability to effectively participate in this venue.

One example is that defendants' now require a copy of the filed Answer to Complaint and Counterclaims, filed with the court, to facilitate service of counter-claim defendants, but have yet been able ascertain how to acquire the required documentation without assistance as requested herein.

Defendants are still acting pro-se and serious complications have delayed the facilitation of legal representation to appear on behalf of defendants, including at least Western Import Manufacturing Distribution Group Ltd.

I respectfully request that I be allowed to participate in Electronic Case Filing or, in the alternative, receive email copies of court filings when filed (including documentation relating to defendant Western Import Mfg. If you would kindly assist to facilitate this matter by directing or allowing the clerk of the court to either allow us to participate by electronic case filing or by email to ensure that defendants are apprised prior to the adjudication of matters pending before the court relating to this proceeding so that defendants may participate. Also, I respectfully submit that if you would allow my request then inconvenience to the clerk of the court would be minimized as telephonic communications, etc., would be reduced.
