DETAILED ACTION

Allowable Subject Matter

1. Claims 3-9 are allowed.

The limitation which is primarily responsible for distinguishing the claims of this application over the prior art is the limitation concerning the circuit board not extending into the space shared by the speaker and the antenna. Proper motivation for combining references disclosing this limitation with the references which disclose the other limitations recited in the claims of this application could not be found in the prior art.


