In light of recent developments including Google's announcement of its intention to merge with Motorola Mobility, I write to request the supplementation of responses provided by Motorola Solutions, Inc. and Motorola Mobility, Inc. (collectively, "Motorola") to Apple's Interrogatories and Requests for Production of Documents in the above-referenced Wisconsin Florida matters. Specifically, we request that Motorola supplement its responses to Apple's discovery requests including, but not limited to, Wisconsin Interrogatory No. 14; Wisconsin Request for Production Nos. 4, 7, 10, 33, 37-39, 41, 44, 45, 58, 59, 68, 79, 80, and 82; and Florida Request for Production Nos. 5, 7, 10, 32, 35-37, 39, 42, 43 and 62.

I note that in its responses to several of the identified Requests for Production, Motorola stated that it is willing to meet and confer to discuss the information sought by the request. Please let me know when you are available this week to meet and confer regarding the timing of Motorola's supplemental responses.
