Please note well my SCISSORS was stolen by deputies at the jail that night. It cost \$3.00. I had to replace it.

If I have not stated it yet to you all yet (I did in my federal court complaint in MADISON this Tuesday 6/14/2011) There was again Police Brutality on this case by MR. TUREK - ^{white male} ^{no glasses} allegedly with the Sheriff's Dept. and by MS Medina who wrote the ticket. They are some brutal piece - and all the time she, the only woman Sheriff's Dept. Deputy on the scene, pretending to care about me and never telling me she was writing the ticket. In that common large area of the jail we had at least 2 other brutish Sheriff Dept. deputies - one colored dark male, one white male. I am swearing to all this so help me God.

PS. I did not tell the jail nurse in the jail I had not been physically hurt by the deputies. It would be a lie. Both my arms have been broken in the past and my right foot toes I am 70 years old + have trouble with my right knee.

Did someone get a 1000.00 reward for having me arrested + jailed?
The young men on the bus driver the same who called someone?
BN - MS. Medina + MR. TUREK left together + got to the jail.
