This is a common practice in prisoner litigation under Section 1983. A proponent has no right to demand that the respondent go first, then determine if the proponent wishes to respond because this would turn the court's procedure on its head. At most, a proponent may seek leave of court to rebut a respondent's expert; any such motion for leave would have to persuade the court that this would not result in sandbagging.
