(Dkt. # <u>22</u> .) In his motion, Morris cites several cases for the proposition that prison officials may not prevent a prisoner from litigating his claims, including a decision

		from this district holding that a prisoner's right to access to the court was violated when the prison denied him the proper materials or postage to submit evidence in response to a motion for summary judgment. <i>Ripp v. Nickel</i> , No. 10-cv-492-bbc, dkt. #48 (W.D. Wis. Mar. 14, 2012). Here, however, Morris has yet to show that he is being denied access to the courts. Although Morris claims that he has a multitude of exhibits that are relevant to his claim, he has already filed a complaint and amended complaint, which are currently under advisement for screening. Thus, he is not currently facing any impediment to litigating this matter. Furthermore, Morris recently filed a 52-page amended complaint in his other lawsuit pending before this court, which indicates that WSPF staff are not impeding his ability to file necessary documents in his cases. See <i>Morris v. WDOC</i> , No. 15-cv-564-wmc, dkt. #17 (W.D. Wis. Mar. 21, 2016). Since Morris has not been denied access to the court during the course of this lawsuit due to a lack of funds, his motion for reconsideration is DENIED. Signed by District Judge William M.
